Greetings for the day!

It is submitted that Model code of conduct is already in place for General Elections 2019 and as per trailing mail from Govt of India following activities are to be done on websites of the Departments

1. Photograph of political functionary at official website- ECI instruction contained in letter No. 437/6/INST/2014-CC&BE dated 20th March, 2014 provides that all references of Ministers, Politicians or political parties available on central/state Government's official website, shall be removed. The CEOs have to take immediate action to remove/hide the photographs of any political functionary from official websites of state department.

2. The Commission has decided that during the period when Model Code of Conduct is in force in connection with General Election to the Lok Sabha/State Legislative Assemblies currently going on, all references of Ministers, Politicians or Political Parties available on such Central/State Government's official website, shall be removed.

You are requested to ask the departments under your administrative control to do the needful with regard to content of web portals accordingly.
